General Incorporated Association Nonprofit Organization World Soccer Clinic Terms and Conditions

Chapter 1 General Provisions

(the purpose)

Article 1

The purpose of our organization is to create an environment where children can receive instruction directly from those who have experience coaching in the world's first tournaments, or from coaches who understand the content of the instruction, and create opportunities for athletes to challenge the world. shall be.

(Activities)

Article 2 In order to achieve the purpose set forth in the preceding article, our corporation will conduct the following activities.

- (1) Regular practice
- (2) Various foreign games (including practice games, official games, and away games)
- (3) Training camp
- (4) Other activities necessary to achieve the objectives of our corporation

(recess)

Article 3 If you are unable to participate in various activities due to injury, illness, or other legitimate reasons, notify the General Manager of your intention to suspend the session in advance.

Membership fees during the recess period will be waived only if the procedures set forth in the preceding paragraph are followed.

(withdrawal)

Article 4 If you wish to withdraw from membership due to unavoidable circumstances, notify the General Manager of your intention to withdraw from membership.

Apply to our corporation by the end of the month in which you wish to withdraw from membership. Even if you cancel your membership midway, your membership fee for that month will not be refunded.

Article 5: In the unlikely event that an accident occurs that is not covered by sports accident insurance, our corporation will not be responsible for it.

Chapter 2 Others

(Participation in various activities)

Article 1 Management of our corporation

(Membership)

Article 2: Persons wishing to join our corporation shall apply with the consent of their guardians.

Article 3: The application for membership will be completed after the application is approved by the representative.

(withdrawal)

Article 4: Withdrawal of membership will be permitted in the following cases:

1. When a representative requests to withdraw from membership.

- 2. When it is confirmed that the person repeatedly engages in words and actions that are critical of the coaches, guardians, members, other team leaders, guardians, members, referees, etc. of our corporation.
- 3. When not following the instructor's instructions.
- 4. When there is any behavior or behavior that causes the loss of trust in our corporation.
- 5. When a guardian engages in behavior that constitutes guidance for a player.
- 6. When a parent or accompanying person uses the ball between practices or games.
- *In addition to the above, withdrawals may be made at the discretion of the instructor.
- *If the instructor decides to withdraw from membership, we will not inform you of the reason.
- OChapter 6 Supplementary Provisions
- Article 1: Always have a heart of gratitude and act with a spirit of respect.
- Article 2: Parents should say positive words to the players (good luck, good luck, etc.) during practices and games.
- Article 3: Parents are prohibited from speaking to players regarding guidance during practices and games.
- (This is because players end up looking at their parents' faces, which interferes with their ability to think and make decisions on their own.)
- Article 4: Recognize the play that players make on their own, and praise them for trying even if they fail.
- (When you try something like a volley shot or a heel lift, it is strictly forbidden to say things like "What are you doing something like a circus?" ⇒ If you are denied that you are interested in trying something like that, you may want to try something easier. (This excludes plays that threaten the safety of opposing players and abusive language.)
- Article 5: Parents are requested to cooperate in creating an environment where players can enjoy playing football.
- Article 6: If a player is injured due to contact with an opponent, the opponent will not be charged for medical expenses, etc.
- Parents should be aware of the possibility of injury while playing sports and take precautions such as purchasing insurance. Please be aware in advance that if you do not take precautions such as enrolling in insurance, you will be responsible for your own treatment costs, including if the treatment is not free of charge due to local medical expense subsidies.
- Article 7 Participating players are prohibited from using smartphones (including kids' cell phones) when participating in activities such as practices, matches, and game days, or when leading the charge.
- However, even if we are careful, we cannot control the number of children who secretly play with their smartphones, so we will collect the items when the above activities gather and return them when the activity ends.

It is not acceptable to be late for the meeting time due to playing games on your smartphone, interacting with friends, etc.

If a player fails to abide by the above rules, that player will no longer be allowed to bring his/her smartphone into practices and matches.

Reference: Kanagawa Prefecture has established an ordinance that focuses on the safe and appropriate use of bicycles and the mandatory participation in bicycle liability insurance.

(Additional provisions)

Article 7 These Terms will come into effect from August 6, 2020.
